Notice to European Union Users

IRIS DESIGNS LLC's operations are located primarily in the United States. If you provide information to us, the information will be transferred out of the European Union (EU) and sent to the United States. (The adequacy decision on the EU-US Privacy became operational on August 1, 2016. This framework protects the fundamental rights of anyone in the EU whose personal data is transferred to the United States for commercial purposes. Your Rights as a Data Subject

- **The right to restrict processing:** this means you can change your communication preferences or opt-out of certain communications. You can do this by sending an email to Info@irisdesigns.biz.

Security
